This office accepts the 1-9-2006 letter from Mrs. Carl Mock, Board Chairman, designating Ms. Lenda Wilson "as an official to make and sign commitments on behalf of the Michigan City Housing Authority." (MCHA), MCHA's 1-19-2006 Fax cover & revised four (4) page "Brief RHF Plan" with Mrs. Mock's attached 1-9-2006 cover letter is accepted & approved. This 1st Increment RHF "Brief Plan" was submitted as a follow-up corrective refinement after meeting the HUD required November 15, 2005 deadline. The following is a brief overview and clarifications of MCHA's accepted & approved 1st RHF Increment "Brief" Plan for RHF 2004-08 grant years.

RHF Plan milestones proposed:

1. Field Office RHF "Brief Plan" approval sets the stage to accumulate all five (5) years of RHF grants for this "Brief Plan" as requested, however, it remains subject to, i.e. HUD regulatory governing standards on current & future grants.
2. MCHA estimates total funds @ \$479,788. This estimate uses the R-501-05 grant @ \$90,255. as a basis for 2006-2008.
3. Acquire five (5) single family (S/F) scattered-site homes as public housing units with only RHF funds.
4. Development Method is: "...acquisition with necessary rehabilitation of units from "Michigan City Development Inc. (Not-For Profit), previously constructed with non-governmental funds."
5. One 2-bedroom, Two 3-bedroom & One duplex home with Two 3-bedroom units for a total of 5-S/F public housing units.
6. MCHA indicates the following relating to the need for architectural services: "Current plans are to work with trained REAC inspectors for physical inspections to ensure all (5) public housing units meet all applicable standards. If we are unable to comply by this method, an architect will be hired."
7. MCHA states: RHF public housing units will meet all applicable standards; i.e. Site acquisition, State & Local, HUD-UPCS & "Decent, safe, Sanitary-Good Repair", Accessibility, Energy Star & Lead Based Paint, as applicable, standards. Total Development Costs Applicable (TDC) will be met at time of HUD approval of the "Development Proposal"
8. As indicated & discussed, this "Brief Plan" is open to modification until the "Development Proposal" is approved, but remains subject to HUD current & future regulations & policies.
9.
